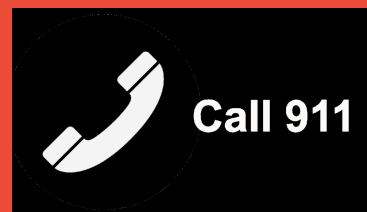


EHS to Host CSHEMA Symposium

For Campus Emergencies, Call 911 on Cell Phone or Land Line

For many years, Princetonians were instructed to call 609-258-3333 on their cell phones in case of emergency to ensure the call reached campus dispatch. **This is no longer necessary:** 911 can be called on any phone to reach emergency services.



Remember, the **TigerSafe App** offers quick-touch 911 as well as non-emergency numbers for Public Safety and other local police departments. Use the "Get Help" button on the home page.

EHS has updated its information on the maintenance and use of fume hoods in the laboratory. Go to the EHS website to learn more about this vitally important equipment.

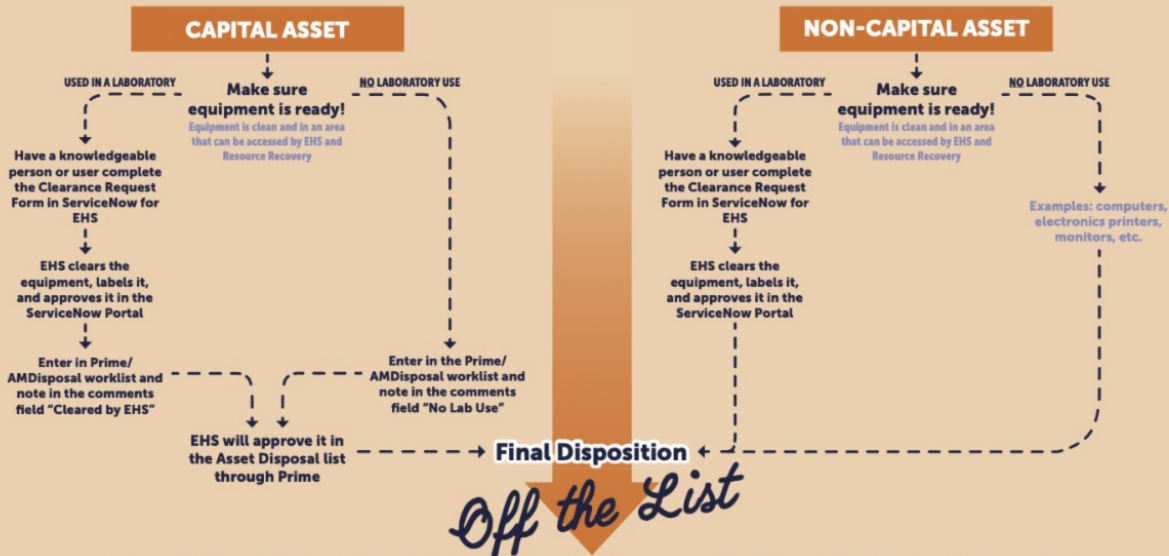

Note: If a capital asset is entered into Prime / AMDisposal worklist for EHS disposal approval and the equipment is no longer physically on campus, please state this in the comments.

COVID Updates: Masks, Signage and Clinics

With the **lifting of the mask mandate** in March, face coverings are optional in most University spaces, with some exceptions. Learn more on the [Safe Practices page](#) of the Covid Resources site.

'Wear a face covering inside' signs may be kept on exterior doors. Building visitors are encouraged to use the QR code on the sign to read the updated guidance. Departments can find [PDF versions](#) of approved COVID-19 signs for printing, as well as [more information](#) about building signage, on the EHS website.

Departments may still order KN95 masks through EHS at cost, which is .53 per mask, using the [COVID-19 PPE and Supply Request Form](#). KN95 masks are found under the category "Eye and Face."
